Index Objective

Dates

Snapshot Dates: The last trading day of Feb and August.

Reconstitution Dates: Indexes reconstituted semi-annually on the third Friday of March and September.

Weight Date: The close of trading on the day before the second Friday of the rebalancing month.

Rebalance Dates: Indexes are rebalanced quarterly on the third Friday of the last month of each calendar quarter.

Selection

All constituents of the Universe which meet the following criteria:

Minimum ADTV: 100K USD

Minimum Days Traded: 22 days in last 3 months

Weighting

Country/Sector weights are calculated based on a fixed company weight multiplier with benchmark country and country sector weights constrained to closely match the universe country sector weights. Excess weight is redistributed hierarchically within region/sectors¹, countries, sectors, and securities. Security market cap weights are then scaled by the final country/sector weights. Individual security weights are capped at 10%.

Rebalancing and Reconstitution

The Indexes are rebalanced on the "Rebalance Date" and additionally reconstituted on the "Reconstitution Date".

Pricing used in share weights used for reconstitutions are as of the "Weight Date".

Share weights for the rebalanced Indexes are computed as of the "Weight Date".

Changes to the Indexes related to the rebalances are as of the "Rebalance Date".

Additions are only made on reconstitution dates.

Index Maintenance

Deletions are made at any time, in the event a stock is liquidated, de-listed, files for bankruptcy, is acquired, or merges with another stock.

The Market Cap Weighted Index Merger Approach 2.0 which considers the deal terms is used when the acquirer is a component stock of the index.

¹ Developed Regions: Asia ex Japan, Japan, Europe ex United Kingdom, United Kingdom, and Canada. EM Regions: Emerging APAC, India, China, Emerging Americas, Emerging Europe & Africa.
